1. Tourist Visa "TR" – for tourism purposes only (can stay for 60 days)¹

- ☑ Completed visa application form, with a recent passport photo affixed
- ☑ Copy of passport
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia

2. Special Tourist Visa "STV" – for tourism purposes only (can stay for 90 days)²

- ☑ Completed visa application form, with a recent passport photo affixed
- ✓ Copy of passport
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia
- ☑ Duly legalised criminal record, issued within the last 3 months
- \square Duly legalised medical certificate, issued within the last 3 months³
- ✓ Health insurance certificate issued by a Thai insurer⁴
 - Covers at least 90 days or the whole period of stay
 - has outpatient benefit of not less than 1,300 EUR
 - has inpatient benefit of not less than 13,000 EUR
 - covers all medical expenses including COVID-19 at least 100,000 USD
- ☑ Evidence of accommodation for at least 90 days or the whole period of stay, either
 - Fully paid hotel reservation⁵
 - Fully paid residential lease⁶
 - Hire-purchase or mortgage agreement
 - Condominium title deed

3. Non-Immigrant Visa "O" (can stay for 90 days)⁷

3.1 For retirees aged 50 and over ("O-Retirement")

- ☑ Completed visa application form, with a recent passport photo affixed
- ☑ Copy of passport
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia
- ☑ Proof of retirement status, e.g. notification of pension.
- ☑ Proof of monthly income of not less than 1,000 EUR per month

- If the monthly income is lower than required, please provide a copy of bankbook with the remaining balance of at least 5,000 EUR
- ✓ Health insurance certificate⁸
 - Covers at least 90 days or the whole period of stay
 - has outpatient benefit of not less than 1,300 EUR
 - has inpatient benefit of not less than 13,000 EUR
 - covers all medical expenses including COVID-19 at least 100,000 USD

3.2 For those visiting non-Thai family living/working/studying in Thailand

- ☑ Completed visa application form, with a recent passport photo affixed
- ☑ Copy of passport of the applicant
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia
- ☑ Proof of relationship with the non-Thai family member in Thailand: copy of marriage certificate, birth certificate, registration of legitimate child or adoption certificate
- ☑ Copy of the visa or work permit of the non-Thai spouse, parent, or child who is currently living/working/studying in Thailand
- ☑ Evidence of adequate finance (20,000 THB per person and 40,000 THB per family)

3.3 For spouses, parents, and children of Thai nationals

- ☑ Completed visa application form, with a recent passport photo affixed
- ☑ Copy of passport of the applicant
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia
- ☑ Proof of family relationship with the Thai national: copy of marriage certificate or birth certificate, registration of legitimate child, household registration certificate or adoption certificate
- ☑ Proof of Thai nationality of the Thai family member, such as copy of passport, ID card or household registration certificate
- ☑ Evidence of adequate finance (20,000 THB per person and 40,000 THB per family)
- ✓ Additional document required for spouses of Thai nationals
 - proof of income, either party or both must have a total income of not less than 1,000 EUR per month

- ☑ Letter from the organisation (signed by the head or authorised officer of the organisation) addressed to the Royal Thai Embassy in Vienna
 - confirms that the applicant has been accepted/invited
 - indicates the applicant's role/position and duration of stay in Thailand
 - requests for issuance of non-immigrant "O" visa for the applicant
- ☑ Copy of the organisation's operation license/registration certificate issued by the competent Thai authority
- ☑ Proof of the applicant's education and work experience

3.5 For those who will be a contestant or witness for the judicial process

4. Non-Immigrant Visa "O-A" (long stay - can stay for 1 year)⁹

 - original payslip with a monthly income of not less than 65,000 THB, or
 - deposit account + a monthly income, totalling not less than 800,000 THB
- ☑ Duly legalised criminal record, issued within the last 3 months
- \square Duly legalised medical certificate, issued within the last 3 months¹⁰
- ✓ Health insurance policy document issued by a Thai¹¹ or foreign insurance company stating that the applicant is medically insured for general illnesses, including COVID-19, with a sum insured of not less than 100,000 USD or 3,000,000 THB.
- ☑ Foreign Insurance Certificate as stipulated by the Office of Insurance Commission and Health Insurance of Thailand, which must be completed, signed and stamped by the insurance company.¹²

5. Non-Immigrant Visa "B" (for business/working purposes)¹³

5.1 For those who wish to work or be on a paid internship in private companies

- ☑ Completed visa application form, with a recent passport photo affixed
- ☑ Copy of passport
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia
- ☑ Copy of employment contract, indicating rationale for employment, salary, position and qualifications (the contract must be signed by authorised managing director and affixed with the company's seal)
- ☑ Letter from the company addressed to the Royal Thai Embassy in Vienna, requesting for a visa, specifying name, position, period of employment, salary, education, and job experience of the applicant
- ☑ Copy of corporate documents of the company in Thailand:
 - business registration and business license
 - list of shareholders
 - company profile
 - details of business operation
 - list of foreign workers stating names, nationalities and positions
 - map indicating location of the company

- value-added tax registration (Por Por 20)
- document indicating the number of foreign tourists (for tourism business only), or documents indicating export transactions issued by banks (for export business only)
- Please note that proof of company certificate in Thailand must be certified by the Registrar within the previous 6 months
- ☑ Proof of education and work experience of the applicant
- ☑ For those who already have permission to work in Thailand:
 - Copy of Work Permit issued by the Ministry of Labour, or
 - Letter of approval from the Thailand Board of Investment, or
 - Letter of approval from the Industrial Estate Authority of Thailand, or
 - Letter of approval from the Ministry of Labour (WP.3)¹⁵
- ☐ Those who have not yet received permission to work in Thailand (i.e., those without work permit/approval letter from Thai authority) must provide additional evidence of adequate finance, either
 - 6-month bank statement with funds not less than 500,000 THB (15,000 EUR) maintained throughout 6 months, or

5.2 For those who wish to work in private educational institution / school

- ☑ Letter from the institution addressed to the Royal Thai Embassy in Vienna, requesting for a visa specifying name, position, period of employment, salary, education, and job experience of the applicant
- ☑ Copy of the license to establish an educational institution issued by the Private Education Commission / governmental competent authority
- ☑ Recommendation from the former employer on the applicant's teaching

- ✓ Letter of invitation by the company in Thailand addressed to the applicant or the applicant's company, indicating the purpose and period of the visit. The company must have a registered capital not less than 2 million THB.
- ☐ Document certifying that the applicant is legally employed in Austria, Slovakia or Slovenia (e.g., a confirmation letter from the company in Austria, Slovakia or Slovenia where the applicant is currently employed)
- ☑ If self-employed, proof of financial evidence and corporate documents are required (bank statement, annual tax invoice, etc.)
- ☑ Letter from the company in Thailand addressed to the Royal Thai Embassy in Vienna, requesting for a visa, stating the objective and intended period of the applicant's visit to Thailand.
- ☑ Copies of corporate documents of the company in Thailand:
 - business registration and business license

6.1 For those who wish to attend <u>public schools</u> (colleges, universities, etc.)

- ☑ Copy of passport
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia
- ☑ Letter of acceptance from the institution
- ☑ Letter from the institution addressed to the Royal Thai Embassy in Vienna, requesting for visa "ED" to be issued for the applicant

6.2 For those who wish to attend <u>private schools</u> (colleges, universities, etc.)

- ☑ Completed visa application form, with a recent passport photo affixed
- ☑ Copy of passport
- ☑ Copy of registration of residency of Austria, Slovakia or Slovenia if you are not a citizen of Austria, Slovakia or Slovenia
- ☑ Letter of acceptance from the institution
- ☑ Letter from the institution addressed to the Royal Thai Embassy in Vienna, requesting for visa "ED" to be issued for the applicant

- ☑ Letter confirming the applicant's student status or admission at an academic institution
- 7. Official Visa "F" (for holders of blue UNLP and official passports)
- 8. Diplomatic "D" (for holders of red UNLP and diplomatic passports)
- 9. Non-Immigrant Visa "F" (for holders of ordinary passports wishing to perform official duties in Thailand or to visit/stay with their spouse/parent/child who holds "F" or "D" visas)
 - ☑ Completed visa application form, with a recent passport photo affixed
 - ☑ Copy of passport of the applicant
 - Note Verbale issued by the Ministry of Foreign Affairs/Embassy of the sending State or international organisation, clearly stating the names and positions of the applicants, the purposes of entry, intended date of arrival, duration of stay and any other relevant information
 - ☑ For Diplomatic "D" visa, the Note Verbale should also indicate the name and position of the diplomatic officer whom will be succeeded by the applicant.
